- 3. Based on a review of the evidence in the case and information pertaining to this offense acquired subsequent to the filing of the Felony Indictment, the Government has concluded that further prosecution of the defendant, CARLOS EKMEIRO, would not be in the interests of justice.
- 4. In light of the foregoing, I recommend that an order of nolle prosequi be filed as to defendant EKMEIRO with respect to Indictments, S3 04 Cr. 219 (DAB), S2 04 Cr 219 (DAB) and S1 04 Cr. 219 (DAB).
